# ADVANCING THE HERCULES PROJECT

#### Advanced, 100% Owned Silver Asset

 The Hercules Project is a disseminated silver-lead-zinc system with 28,000 m of historical drilling in >300 holes, across 3.5 km of strike, open in all directions

#### Multiple Drill Ready Targets

- Grandfathered mining rights to the land
- Soil & rock sampling, geological mapping & geophysics completed in 2022 - all targets drill-ready
- Phase I maiden drill program completed Nov 2022 – results pending
- Phase II drill program slated for Q2 2023

#### **Location & Infrastructure**

- Idaho is ranked one of the best jurisdictions in the world for mining by the Fraser Institute
- Project is 2.5 hours from Boise, accessible by highway year-round

### **Fully Funded for Drilling**

• Strategic investment made by Crescat Capital in 2022

#### **Silver Dominant Grades**

• The value of the mineralization comes mostly from silver, with subordinate lead and zinc, giving strong leverage to a rising silver price environment




### **EXPLORATION**

3D IP survey over the Hercules Adit, Frogpond and Belmont Zones identified a large untested chargeability anomaly below the historical drilling

- Strong chargeability values (>25ms) over a continuous strike length of 1.8 kilometers
- Anomaly is coincident with the untested base of the Hercules Rhyolite where surface mapping indicates the strongest silver mineralization to occur
- Lower portion of anomaly lies down dip from copper-silver+/-gold mineralization hosted within the underlying Seven Devils volcanics
- Anomaly remains open up-dip to the southeast
